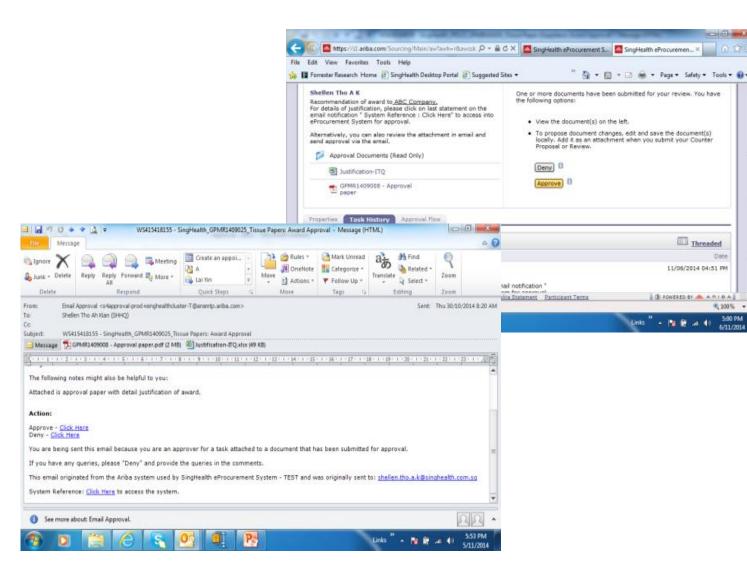
Fully implemented a standardized end to end procurement tool on a single platform, to rest of 9 institutions in 2015 (by phrases).

Conclusion

- Streamlined Procurement processes and eliminated non-standardized process.
- Governance process in place with pre-configured requisition approvers per Finance policy and award approval aligning to Procurement Policy
- Approvers approve via email or through system
- A global solution with suppliers' network
- Users use online catalogue features for routine or repeated ordering of contracted products from stores
- Purchase orders are system-generated, thus, minimize procurement data error.
